Non-accessible content

- Criterion: 9.1.1.1 Certain non-text content that is presented to the user does not have a text alternative that serves the equivalent purpose;
- Criterion: 9.1.2.2 Captions are not provided for certain prerecorded audio content in synchronised media;
- Criterion: 9.1.2.5 Audio description is not provided for certain prerecorded content in synchronised media;
- Criterion: 9.1.3.1 Certain information, structure and relationships conveyed through presentation cannot be
 programmatically determined or are not available in text;
- Criterion: 9.1.4.1 For certain elements, colour is used as the only visual means of conveying information, indicating an action, prompting a response, or distinguishing a visual element;
- Criterion: 9.1.4.3 The visual presentation of text and images of text does not always have the minimum requested contrast ratio, aside from the exceptions provided for in the regulation (e.g. logotypes);
- Criterion: 9.1.4.11 In certain visual representations, the contrast ratio of at least 3:1 against adjacent colour(s) for user
 interface components and/or graphic objects and/or graphic parts necessary to understand the content has not been
 observed;
- Criterion: 9.1.4.13 In certain cases, where receiving and then removing pointer hover or keyboard focus triggers additional
 content to become visible and then hidden, there is no available mechanism to dismiss the additional content without
 moving the pointer hover or keyboard focus, the pointer hover cannot be moved over additional content without it
 disappearing or the additional content does not remain visible until the hover or focus trigger is removed, the user dismisses
 it, or its information is no longer valid;
- Criterion: 9.2.1.1 Certain functionality is not operable through a keyboard interface;
- Criterion: 9.2.4.1 There is no mechanism available to bypass blocks of content that are repeated on multiple Web pages;
- Criterion: 9.2.4.3 On certain Web pages that can be navigated sequentially and the navigation sequences affect meaning or operation, certain focusable components do not receive focus in an order that preserves meaning and operability;
- Criterion: 9.2.4.6 Certain headings and/or labels that describe topic or purpose are missing;
- Criterion: 9.3.3.1 In certain cases, if an input error is automatically detected, the item that is in error is not identified and/or the error is not described to the user in text;
- Criterion: 9.3.3.2 In certain cases, labels or instructions are not provided when content requires user input;
- Criterion: 9.4.1.1 In content implemented using markup languages, certain elements do not have complete start and end tags, are not nested according to their specifications or do not contain duplicate attributes in order that any IDs are unique, aside from where the specifications allow these features;
- Criterion: 9.4.1.2 For certain user interface components (including but not limited to: form elements, links and components
 generated by scripts), the name and role cannot be programmatically determined; states, properties and values that can be
 set by the user cannot be programmatically set; and notification of changes to these items is not available to user agents,
 including assistive technologies;
- Criterion: 9.4.1.3 In certain content implemented using markup languages, status messages cannot be programmatically
 determined through role or properties such that they can be presented to the user by assistive technologies without
 receiving focus;
